Additional Information	<ul style="list-style-type: none"> <li>➤ Having rendered public service for over 35 years as a member of the Indian Administrative Service, he rose to the highest post of Chief Secretary and retired from that post on 30.04.2018</li> <li>➤ He shot into prominence while he was Jaipur Development Commissioner (October 1999 to January 2002), raised huge resources for the JDA and carried out city-wide development works, which included re-development of JLN Marg and Bhagwan Das Road, development of Central Park and construction of scores of slip lanes, over bridges and flyovers as also regularization and development of hundreds of housing societies/ projects.</li> <li>➤ As CMD of Jaipur Metro Rail Corporation Ltd. (April 2012 to February 2016), he is credited with the completion and commissioning of Phase 1A of Jaipur Metro (June 2015) and the planning and launch of its Phase 1B while taking due care of the protection of heritage monuments in the walled city (Pink City).</li> <li>➤ As Additional Chief Secretary, Forest, Environment, Tourism, Art &amp; Culture (February 2016 to December 2017), he is credited with</li> </ul>		

		<p>various initiatives that rejuvenated and revitalized Ranthambhore Tiger Reserve and various other wildlife areas, led to the planting of 25+60=85 lakh trees in Phase I and II of MJSA (Mukhyamantri Jal Swavlamban Yojna), swelling of tourist arrivals to 475 lakhs in 2017 and the National Tourism Award for comprehensive development of Tourism getting conferred on the state.</p> <ul style="list-style-type: none"> <li>➤ As Chief Secretary, Rajasthan (January – April 2018), he achieved a high-level of co-ordination among various departments and wings of the government, to improve delivery of services and to gear up a large number of developmental projects and schemes across the State.</li> <li>➤ As Chairman, Rajasthan RERA (March 2019 to April 2023), he became widely known for an order passed by him and upheld by the Hon'ble Supreme Court. In this order, he had held that interest of a buyer/allottee is superior than the interest of banks and other secured creditors; and, therefore, claim of a buyer/allottee over an allotted apartment in a project will take precedence over the claims of a bank for recovery of its loan from the promoter of the project.</li> <li>➤ Earlier, he has written a book titled "Resource Mobilization Strategy for Indian States: A case Study of Rajasthan" which was awarded by the State Government as an original work of outstanding merit.
